STEPS IN DUBAI E-VISA PROCESSING	
STEP 1: ASSESSMENT	<p>Read and sign our Data Privacy Agreement & Visa Waiver then email it together with the accomplished Questionnaire for Free Assessment, this will allow us to evaluate your chances of approval. STEP 2: PAYMENT	<p>After the assessment and should you wish to proceed with the application, our Visa team will then provide your invoice. Proceed to settle then send your proof of payment along with the complete requirements.</p>
STEP 3: ENDORSEMENT & PROCESSING	<p>The Visa Team will endorse you to the next available Visa Consultant, who will verify your payment before proceeding with the processing of your application.</p>

- ☐ Scanned copy of Passport Bio Page with at least 12 months validity prior to departure (make sure page 3 is signed)
- ☐ Scanned copy of Passport size photo (4.5cm x 3.5cm) with white background
- ☐ Scanned copy of all visas & all passport pages with travel stamps of the countries that applicant had visited for the past five (5) years
- ☐ If employed, copy of COE and ITR
- ☐ If Business Owner, copy of valid Business Documents (DTI/SEC, Mayor's Permit, BIR 2303 and ITR)
- ☐ Copy of confirmed airline ticket
- ☐ Copy of confirmed hotel booking

TERMS AND CONDITIONS

- Applicant(s) must have a stable source of income here in the Philippines (Employed, Business Owner or Self-Employed)
- All Visa applications are for single entry only and valid for up to 30 days stay.
- Visa approval is at the discretion of the Visa officers. We cannot guarantee 100% approval.
- Visa processing takes five (5) to ten (10) working days and will be applied 30 days before the travel date since the validity of the visa is only 60 days. It must be used before it expires.
- Immigration Working Days: from Sunday to Thursday only.
- Once Application is submitted to Immigration Department, the Visa Application Fee is non-refundable.
- Visa Extension is not allowed.
- In any case of delayed results and/or refusal of application, Travel Online Tours shall not be held liable for the costs of airline ticket(s) and hotel accommodation(s).
